Apropos to the Press Release brought out by Pu Khaikhohauh Gangte on behalf of the Kuki Inpi Manipur on 18^{th} June 2023. As a true Gangte, the press release is replete with humour. For example, in the Press Release, para three, there is this statement, "Our condolences to all those killed and injured at Khamenlok and we advise the rational-sane Meiteis to 'Stay Home, Stay Safe. And don't come and die at our Villages'". Your esteemed self must be proud of this ancestral trait that makes us laugh for a while and forget about all the evils that the Kuki militants are committing at present.

You know, *Pu* Gangte has pulled a cruel joke at the cost of the departed souls just like the Gangte ancestors could pull a joke that goes like this: "Heaven shall be bliss if there are no mosquitoes and Paites".

It is a different story that the Kukis massacred the Paites way back in 1997–1998 to control Churachandpur town. Apart from this economic reason, there was/is a deeper sociological factor, that is, the Kukis simply despise the nomenclature 'Zomi' and instead wanted the Paites to be called 'Kuki', which the Paites considered to be a foreign 'slang' word. You hegemonic scheming infidels! However, we appreciate the fact that the two communities have buried the hatchet except that their combined militants, the narco-terrorists, using illegal immigrants are waging a war against the Meiteis under the nomenclature of Kuki-Zo.

The purpose of this lengthy quotation is to educate you on the need for an unbiased introspection and analysis of the provisions of the Indian Constitution. Do we need to remind you of your aggressions against other communities, such as in Manipur against the Kabuis and the Tangkhul during 1917–1919, against the Hmars in 1959–1960, against the Nagas in 1992–1997, against the Karbis in Assam in 2003–2004? Beyond this realm, you have been fighting with the Burmese (Myanmarese), the Shans and the Kachins in Myanmar. Further, in your jest to be called one of the lost tribes of Israel, few of your people has put as human shields at the Gaza Strip and fighting against the Arabs, Palestinians to be precise.

How much you like war! Imagine, teachers like Prof. Kham Khan Suan Hausing of University of Hyderabad and Dr. Thangkholal Haokip from Jawaharlal Nehru University, New Delhi and politicians like Wilson Lalam Hangshing joining the war cry like blood thirsty Nazi scholars and declaring war against the Meiteis in live telecast national TV shows. They negate dialogue for peaceful settlement just like you. What have you created? You owe an explanation to humanity if not the Meiteis. You all are responsible for the blood cuddling violence and misery in Manipur.

We pray you do not start a fight with the Jats and Sardarjis in Delhi in your flight of imagination to create a separate administration in NCT. Or with the Khasis, Garos and Jaintias in Mehgalaya or the Mizos just like you did against the Lushais and the Lais in Mizoram (formerly, the Lushai Hills). Learn to live in peace, respect lives, including the sacred buffalo you kill and use its head as your symbol (mascot) of strength.

Furthermore, Article 21 of the Indian Constitution that you quoted also equally applies to your fellow beings and neighbours and owners of the land especially the indigenous people of Manipur. Start respecting lives of others. You need to attend one of the classes on Indian Constitution to understand this complex constitutional provision.

Pu Gangte, do get educated to understand the nuances of Indian politics or the world affairs. Myanmar and Bangladesh are two sovereign nation-states like India. Before, we wind up, let's examine the modus operandi of the Kuki Civil Society Organisations including the Kuki Inpi Manipur of which you're the General Secretary.

- 1. Kuki Civil Society Organisations (CSOs) do not have a sincere stand with regards to illegal immigration, poppy cultivation and protection of reserve and protected forests, sacred sites, wildlife sanctuaries and wetlands. In fact, there is nothing sacred or profane for the Kuki community in the Weberian sense of the terms.
- 2. Illegal immigration, poppy cultivation and settlement in protected forests, sacred sites, wildlife sanctuaries and wetlands besides claiming settlement rights within Reserve Forests continue with their tacit support and encouragement.
- 3. All these illegal activities which have been continuing for decades without any restraint through manipulation of a corrupt system and their high ranking officers. These are against the national interest and it adversely affects the various communities living together in Manipur.
- 4. Truth be told, the BJP Government of Manipur has taken a strong stand against poppy cultivation and for the protection of Reserve and Protected forests, sacred sites, wildlife sanctuaries and wetlands. However, there has been a concerted effort by the Kuki militant backed CSOs to derail or stop the efforts of the government by appealing to the Central Government in the name of tribal rights.
- 5. It has been true with regards to the illegal immigration. Successive Central and Manipur governments have taken a very casual approach towards refugees and illegal immigrants. As a result, although there have been problems of refugees and illegal immigration since the 1950s, the situation has exploded now because of the casual approach in the past.
- 6. Kudos to the leadership of Shri N Biren Singh, the present Manipur BJP Government with support from the Central government for taking up concrete steps to identify the illegal immigrants to protect the indigenous population from the aggression by the illegal Kuki immigrants.
- 7. In the face of the failure of the various illegal activities and the impending failure of their plan to dominate the original inhabitants of Manipur by bringing more illegal immigrants, Kuki militant outfits and their supporters had orchestrated the ejection of Meitei population from Kuki dominated areas by vandalising the properties and burning down of houses of Meiteis in these areas.
- 8. After committing this horrendous crime of ejecting the Meities from the Kuki dominated areas, Kuki CSOs have undertaken a media propaganda campaign to hide their crime and nefarious activities. Various concocted narratives have been floated to appeal to the tribal and religious sentiments tribals being targeted by majority Meiteis, Christian religion being persecuted by burning down churches, etc. Unfortunately, the national and international media succumbed to the version of Kuki CSOs without verification or falsification.
- 9. They have created someone to shift the blame for their crime in the person and office of Shri N Biren Singh, the Chief Minister of Manipur, a constitutional figure, who had been working hard to stop Illegal immigration, poppy cultivation and settlement in protected forests, sacred sites, wildlife sanctuaries and wetlands with popular support for the future generation (Kukis included).
