It will be very grateful if you take up case against Shri Kangjam Birendra Singh, a resident of Haobam Marak, Imphal West, Contact No. 9402678116 and Shri Y. Kiran Singh, a resident of Hiyangthang near Kumari Lampak, Imphal West, Contact No. 9436405819 and 94366885122 for not refunding the deposited money a sum of Rs. 4 Lakhs which had deposited for the proposed trip to participate in the Nations Cup for football above 45 years (Legendary Tournament) scheduled to be held from June 6th - 11th 2023 in France.

It may be mentioned that the two persons Shri K. Birendra Singh and Y. Kiran Singh organizer of AMBA FC invited me to join the programme in France. In this connection, I had accepted the proposal along with my family members and deposited Rs. 2 Lakhs in April and another Rs. 2 Lakhs on 5th May, 2023.

But unfortunately, on 6th May, 2023, I had given information to both of them, Shri K. Birendra Singh and Y. Kiran Singh that myself and my family members would not be able to participate in the foreign visit programme due to unavoidable circumstance. So, I told them to refund the deposited amount of Rs. 4 Lakhs on 6th May, 2023. Since then, the two leaders declined my repeated request and also there is no response to the telephone calls. It seems they are cheater and wrong doer in the name of AMBA FC. So, please take up legal action against the mentioned above persons.
