Developmental Planning in Manipur: Pattern of the Power Sharing of State Government during 1999-2023

Abstract:

Manipur is one of the Border States in the north-eastern part of the country having an international boundary of about 352 kms. long stretch of land with Myanmar on the east. It has a total area of 22327 sq kms of which nine-tenth consists of hills and only one-tenth comprises the valley. The locational disadvantages, topography, land lockness, natural resource base makes the state economically backward. Manipur is inhabited by three major ethnic groups viz (i) Meitei/Meetei, (ii) Nagas and (iii) kuki-Chin tribes. The Meitei pangals (Meitei-Muslims) constitutes as a minority community. Besides these, other communities from the other states of India have also settled in the state. The present paper makes an attempt to estimate the distribution of administrative power to different categories viz (i) Meitei/Meetei(M), (ii) Scheduled Tribes/Tribal(T)(Nagas and kuki-Chin tribes together), (iii) Meitei Pangal (MP), (iv) Manipuri Nepali (MN) and (v) Outsiders(O) during the period of twenty-five years starting from 1999 to 2023. The study concludes that (i) Scheduled Tribe community participated well in the Government administration sharing a reasonable power ratio during the period and the Outsiders played important pivotal role in the Government administration.

Introduction:

Manipur is one of the Border States in the north-eastern part of the country having an international boundary of about 352 kms. long stretch of land with Myanmar on the east. Manipur merged with the Union of India in 1949 as a Part 'C' State and became a Union Territory in 1963. It became a full-fledged State in 1972. Because of its strategic location with a low tax base, it was categorized as a Special Category State. It has a total area of 22327 sq kms of which nine-tenth consists of hills and only one-tenth comprises the valley. The locational disadvantages, topography, land lockness, natural resource base makes the state economically backward. The State is connected by air with Delhi, Calcutta, etc. However, roads continue to be the most important transport system. Two National Highways NH-39(NH-2) and NH-53 connect the State with the rest of the country. NH-39(NH-2) links Imphal with the railway head of Dimapur in Nagaland to the north & NH-53 with Silchar in Assam towards the south west. Imphal-Jiri railway line is in the final stage of completion. Transport system in the State will have a boost when this railway line is fully operational.

Population composition of the State:

Manipur is inhabited by three major ethnic groups viz (i) Meitei/Meetei, (ii) Nagas and (iii) kuki-Chin tribes. The Meitei pangals (Meitei-Muslims) constitutes as a minority community. Besides these, other communities from the other states of India have also settled in the state. The population composition by the classification of religion for the period 1951-2011 are given in the Table-1 & Table-1.1

From the Table-1.1 it is seen that Hinduism population declined from 60.13 % in the year 1951 to 41.39% in the year 2011. The Christianity population increased from 11.84 % in the year 1951 to 41.29% in the year 2011.

Pattern of Power Sharing in Manipur:

The present paper makes an attempt to estimate the distribution of administrative power to different categories viz (i) Meitei/Meetei(M), (ii) Scheduled Tribes/Tribal(T), (iii) Meitei Pangal (MP), (iv) Manipuri Nepali (MN) and (v) Outsiders(O). Period of twenty-five years starting from 1999 to 2023 is covered in the study.

Methodology adopted are:

Fundamental:

- i. Council of Ministers, MLAs, Chief Secretary, Administrative Secretaries, Heads of Departments and Deputy Commissioners are assigned certain weightages to calculate aggregate scores.
- ii. The categories classified are Meitei(M), Tribal(T), Meitei Pangal (MP), Manipuri Nepali (MN) and Outsiders(O).
- iii. Sum of the scores contributed by the Council of Ministers, MLAs, Chief Secretary, Administrative Secretaries, Heads of Departments and Deputy Commissioners are used as the aggregate score for each category.
- iv. List of the Ministers, MLAs, Administrative Secretaries, HoDs and Deputy Commissions recorded in the Government Diaries published by the Information and Publicity Department, Government of Manipur are mainly used as data source. This has been done to maintain data consistency and also to ensure reliability of data source. Apart from that published and unpublished records of the Government of Manipur are also referred to ensure data/record accuracy as far as possible. However, approximation error may still be built in the analysis. Nevertheless, maximum care has taken to avoid avoidable errors.
- v. Assigning of weightages in the present study for different categories has been done to arrive at some empirical values guided by the **principle of path analysis**.
- vi. It has been assumed that duties and responsibilities defined in the conduct rules and procedures of the State Government are strictly maintained by the concerned incumbents. Further, it has also assumed that no external factors influenced in making policy decisions.

Assigning weightages for Heads of Departments:

vii. In the present study Heads of Departments and Deputy Commissioners are treated as the lowest level strata in the power sharing hierarchy.

- viii. Heads of Departments of Twenty-eight departments are chosen in the study. List of the selected 28 departments is given in the Annexure. Departments with higher annual plan provisions are selected. Departments with small/marginal plan provisions are excluded. The total annual plan provision of the selected 28 departments accounts more than 90% of the total annual plan provision. Home Department though budget provision is large is excluded in the present study as the primary objective of the study is focused on economic development.
 - ix. Weightage assigned for a Head of Department (HoD) for a month is 2.
 - x. If the HOD is from Meitei community then a score of value 2 is awarded to Meitei. Similarly, if the HOD is from Tribal community then a score of value 2 is awarded to Tribal. Similarly, if one HoD is identified as Meitei-Pangal/Manipuri-Nepali, then a score of value 2 is awarded to Meitei-Pangal/ Manipuri-Nepali.
 - xi. The total weight assigned for a year is 24(2X12).
- xii. It is also assumed that the incumbent Head of the Department appearing in the Diary holds the post for that year.

Assigning weightages for Deputy Commissioners:

- xiii. Weightage assigned for a Deputy Commissioner for a month is 2.
- xiv. If the Deputy Commissioner is from Meitei community, then a score of value 2 is awarded to Meitei. Similarly, if the Deputy Commissioner is from Tribal community, then a score of value 2 is awarded to Tribal. Similarly, if a Deputy Commissioner is identified as Meitei-Pangal/Manipuri-Nepali, then a score of value 2 is awarded to Meitei-Pangal/ Manipuri-Nepali.
- xv. The total weight assigned for a year is 24(2X12).
- xvi. Some approximations are done as (i) if joined before 15th of a month, one month will be counted, if joined after 15th of the months then nil month will be counted, and will be accrued in the tenure of outgoing Deputy Commissioner.

Assigning weightages for Administrative Secretaries:

- xvii. After Head of Department (HoD), next higher hierarchy in the power sharing pattern in the present study is Administrative Secretary other than Chief Secretary. Secretary/Commissioner/Principal Secretary/ Additional Chief Secretary are assigned same weightage.
- xviii. Weightage assigned for an Administrative Secretary for a month is 4. The reason beingany proposal of HoD may be (i) approved or (ii) declined. There is another provision namely "send down with please discuss". However, this provision is excluded as this will finally will arrive at (i) approved or (ii) declined. As the administrative Secretary has two clear choices over the proposal of the HoD concerned, weightage assigned to any Administrative Secretary is 2x2=4 for a month. Thus, the assigned weightage for an Administrative Secretary for a year 48(4X12).

- xix. If the Administrative Secretary is from Meitei community, then a score of value 4 is awarded to Meitei for a month. Similarly, if the Administrative Secretary is from Tribal community, then a score of value 4 is awarded to Tribal for a month. Similarly, if identified as Meitei-Pangal/Manipuri-Nepali, then a score of value 4 is awarded to Meitei-Pangal/ Manipuri-Nepali for a month.
- xx. The role of other Secretariat Officers like Addl Secretary, Joint Secretary, Under Secretary, etc attached/reported to the Administrative Secretary has been subsumed in the administrative authority of the concerned Administrative Secretary. If weightages are assigned, it is alleged that double counting effect may be built in the allotted weights.
- xxi. List of the Secretary/Commissioner/Pr Secretary/Adl Chief Secretary appearing in the DIPR Diary are adopted as the incumbent Administrative Secretary for the year. It is also assumed that the incumbent Administrative Secretary appearing in the Diary holds the post for that year.

Assigning weightages for Chief Secretary:

- xxii. Next higher hierarchy in the power sharing pattern is the Chief Secretary.
- xxiii. Weightage assigned for Chief Secretary for a month is 8(4X2). The reason being- any proposal of Administrative Secretary may be (i) approved or (ii) declined. There is another provision namely "send down with please discuss". However, this provision is excluded as this will finally will arrive at (i) approved or (ii) declined as explained in previous para. As the Chief Secretary has two clear choices over the proposal of the Administrative Secretaries, weightage value of (4X2) =8 is assigned for a month. Thus, the assigned weightage for Chief Secretary for a year 96(8X12).
- xxiv. If the Chief Secretary is from Meitei community, then a score of value 8 is awarded to Meitei for a month. Similarly, if the Chief Secretary is from Tribal community, then a score of value 8 is awarded to Tribal for a month. Similarly, if the Chief Secretary is from Outside the State, then a score of value 8 is awarded to Outsider for a month.
- xxv. The role of other Secretariat Officers like Addl Secretary, Joint Secretary, Under Secretary, Staff Officer, etc attached to the office of Chief Secretary has been subsumed in the administrative authority of the Chief Secretary.
- xxvi. List of the State Chief Secretaries with their post holding periods available in published and unpublished records are used to calculate the holding period in months. Some approximations are carried out as (i) If joined before 15 of a month, one month will be counted, if joined after 15 of a month then nil month will be counted, and will be counted in the tenure of outgoing Chief Secretary.

Assigning weightages for MLAs:

- xxvii. Next higher hierarchy in this power sharing pattern is the MLAs. An MLA is assigned weightage of 10 for a month. The reason being- the derived and assigned weightage of Chief Secretary for a month is 8 and MLAs are superior to the Chief Secretary in the Government. Thus, the assigned weightage assumed for an MLA for a year is 120(10X12).
- xxviii. If an MLA is from Meitei community, then a score of value 10 is awarded to Meitei for a month. Similarly, if the MLA is from Tribal community, then a score of value 10 is awarded to Tribal for a month. Similarly, if the MLA is from Meitei-Pangal (MP), then a score of value 10 is awarded to Meitei-Pangal (MP) for a month, etc.

Assigning weightages for State Ministers:

- xxix. Next higher hierarchy in the power sharing pattern is the State Minister. A State Minister is assigned weightage of 12 for a month.
- xxx. A State Minister and a State Minister (independent charge) are assigned same weightage of 12 for a month.
- xxxi. If a State Minister is from Meitei community, then a score of value 12 is awarded to Meitei for a month. Similarly, if a State Minister is from Tribal community, then a score of value 12 is awarded to Tribal for a month. Similarly, if a State Minister is from Meitei-Pangal (MP), then a score of value 12 is awarded to Meitei-Pangal (MP) for a month, etc.
- xxxii. Thus, the assigned weightage for a state Minister for a year is 144 (12X12).

Assigning weightages for Cabinet Ministers:

- Next higher hierarchy in the power sharing pattern is the Cabinet, Minister. A Cabinet Minister is assigned weightage of 8X2=16 for a month. The reason being- any proposal of Chief Secretary may be (i) approved or (ii) declined. There is another provision namely "send down with please discuss". However, this provision is excluded as this will finally will arrive at (i) approved or (ii) declined as explained in previous paras. As the Cabinet Minister has two clear choices over the proposal of the Chief Secretary, weightage value of (8X2) =16 is assigned for a month.
- xxxiv. The role of other Secretariat Officers, etc attached to a Cabinet Minister has been subsumed in the administrative authority of the Cabinet Minister. It is to mention that Chief Secretary put up file to Cabinet Minister, if the Chief Secretary is the concerned administrative Secretary in charge.
- xxxv. If a Cabinet Minister is from Meitei community, then a score of value 16 is awarded to Meitei for a month. Similarly, if a Cabinet Minister is from Tribal community, then a

score of value 16 is awarded to Tribal for a month. Similarly, if a Cabinet Minister is from Meitei-Pangal (MP), then a score of value 16 is awarded to Meitei-Pangal (MP) for a month, etc.

xxxvi. Thus, the assigned weightage for a Cabinet Minister for a year is 192 (16X12).

Assigning weightages for Chief Minister:

xxxvii. Chief Minister is in the top in the power sharing hierarchy in the present study. Chief Minister is assigned weightage of 16X2=32 for a month. The reason being- any proposal of Cabinet Minister may be (i) approved or (ii) declined. There is another provision namely "send down with please discuss". However, this provision is excluded as this will finally arrive at (i) approved or (ii) declined as explained in previous paras. As the Chief Minister has two clear choices over the proposal of the Cabinet Minister, weightage value of 32(16X2) is assigned. The role of other Officers, etc attached to the office of the Chief Minister has been subsumed in the administrative authority of the Chief Minister.

xxxviii. If the Chief Minister is from Meitei community, then a score of value 32 is awarded to Meitei for a month. Similarly, if the Chief Minister is from Tribal community, then a score of value 32 is awarded to Tribal for a month. Similarly, if the Chief Minister is from Meitei-Pangal (MP), then a score of value 32 is awarded to Meitei-Pangal (MP) for a month, etc.

xxxix. Thus, the assigned weightage for Chief Minister for a year is 384 (32X12).

Error Analysis:

a. Ministers including Chief Minister:

Generally, Manipur Legislative Assembly elections were held during January-March of the election year. Months during which elections were held during 1995-2022 for Manipur Legislative Assembly are given in the Table-2 below.

Therefore, we find that there are two sets of Ministers/MLAs in election year as (i) set of Ministers/MLAs before election and (ii) set of Ministers/MLAs after Election. The set of Ministers/MLAs before election covered two-three months whereas set of Ministers/MLAs after Election in election year covered nine-ten months. There could be variation in the Category-wise composition in pre-election period and post-election period.

There was President Rule during June-2001 to first week of March 2002. The set of Ministers after Election in this election year covered about ten months. Due to approximation, tenure of MLAs and Ministers were taken as ten months. Duration under PR periods were excluded in calculation.

b. Administrative Secretaries, and Head of Departments:

In the present study, names appeared in the published Government Diary of Directorate of Information and Public Relations (DIPRs) are considered as the incumbent Heads of Departments and incumbent Administrative Secretaries for the year.

Here, the following situations may arise

- (i) Suppose an incumbent Head of Department of a Department was a tribal as per the Diary records, however, the incumbent was transferred to another post or retired during the midst of the year. Two cases arise: (i) the same post was handled by another tribal till the end of the considered year. Then, there will be no error in assigning the weight for Tribal. However, in another case (ii) if the new incumbent was from Meitei community, then there will be error in the estimation as the score for the year has already been assigned for Tribal.
- (ii) Suppose an incumbent Administrative Secy of a Department was a tribal as per the Diary records, however, the incumbent retired in the midst of the year. Then, there will be error for assigning score for the whole year for Tribal. However, in the present study full score for the year is assigned for Tribal.

Estimation of the scores by different categories:

With the above methodologies and constraints, the Category-wise estimations of scores are calculated as given below.

Category-wise scores of Deputy Commissioners:

There were nine districts from 1999 to 2016 in the state of Manipur. The districts were (i) Imphal East, (ii) Imphal West, (iii) Bishnupur, (iv) Thoubal, (v) Chandel, (vi) Churachandpur, (vii) Senapati, (viii) Tamenglong and (ix) Ukhrul.

However, after creation of 7 new districts,16 districts were recorded from the year 2017 onwards. The list of the newly created districts were (i) Kangpokpi,(ii) Tengnoupal,(iii) Pherzawl,(iv) Noney,(v) Kamjong,(vi) Jiribam and (vii) Kakching respectively.

Thus, there were nine Deputy Commissioners for nine districts from 1999 to 2016 and sixteen Deputy Commissioners from 2017 till 2023. Total number of months to be covered in a year by Deputy Commissioners for nine districts are 108(12X9) and 192(12x16) for 16 districts respectively. Category-wise status of Deputy Commissioners for the period 1999-2023 are given in Table-3 below.

From the above Table-3, it is seen that during the period 1999-2023, of the total months available for Deputy Commissioners, 43.07% was covered by Meitei (M), 27.92% was covered by Tribal(T), 2.37 % was covered by Manipuri Nepali (MN) and, 26.64% was covered by Outsiders(O).

From the above Table-3.1, it is seen that during the period 1999-2023, of the total scores of Deputy Commissioners, 43.07% was shared by Meitei (M), 27.92% was shared by Tribal(T), 2.37% was shared by Manipuri Nepali (MN) and, 26.64% was shared by Outsiders(O).

Category-wise scores of Heads of Departments:

Twenty-eight departments are chosen in the study. List of the selected departments is given in the **Annexure**. Departments with higher annual plan provisions are selected. Departments with small/marginal plan provisions are excluded. The total annual plan provision of the selected 28 departments accounts more than 90% of the total annual plan provision. In some years, it was found that the number of Heads of Departments were more than 28. This was due to bifurcation of some Departments into two categories viz (i) Chief Engineer, PHED (Rural) and (ii) Chief Engineer, PHED(Urban) for some years, etc. The status of categorywise selected heads of Departments of Manipur for the period 1999-2023 is given below in Table-4.

From the Table-10.1, it is seen that power shared by Meitei community was lowest with 57.82% in the year 2002 and highest with 63.74% in the year 2000. For the Tribal community lowest was with 27.97% in the year 2008 and highest was with 32.73 % in the year 2002.

From the Table-11.1, it is seen that MLAs scored highest with 56.91% share followed by Ministers sharing 22.16%. DCs scored 2.14% of share of the power.

Yearly category-wise scores by selected Government functionaries:

It has been attempted to see the pattern of power sharing among the categories by the Government functionaries. The shares contributed by the elected representatives are excluded in this exercise. The scores contributed by (i) Chief Secretaries, (ii) Administrative Secretaries, (iii) Heads of Departments and (iv) Deputy Commissioners for the period 1999-2023 are given in the Table-11.2 below. This Table is a sub-Table of the Table-11.

From the Table-11.2, it is seen that power shared by the Meitei and Tribal for the selected Government functionaries were 49.26 % and 22.63% respectively. Outsiders played a pivotal role in the Government functioning sharing 24.72% which is more than the power shared by Tribals.

Power sharing relationship among the categories:

To examine the relationship among the categories during the period of 25 years (1999-2023) Correlation coefficient Matrix has been worked out as given in the Table-12 below.

The Correlation Matrix shows that during the period of 25 years the increase of power for Meitei was associated with the increase of power for Tribal. The coefficient of correlation is 0.8698. Similarly, Meitei had positive correlation with Meitei Pangal, the coefficient of correlation being 0.574. However, the increase of power for Meitei was associated with the decrease of power for Outsiders, the coefficient of correlation being -0.316. Similarly, the increase of power for Tribal was associated with the decrease of power for Outsiders, the coefficient of correlation being -0.25.

Power sharing pattern vis-à-vis category-wise population ratio:

The population composition for the period 1951-2011 for Scheduled Tribe, Islam (Meitei Pangal), Sikhism, Jainism and Meitei population(estimated) are given in the Table-13 below. Meitei population is not directly available. However, it has been estimated as Total population- (Scheduled Tribe population +Islam+ Sikhism + Jainism) in the present study.

From the Table-13.1 above, it is seen that estimated share of Meitei population shows declining trend whereas share of Scheduled Tribe population shows increasing trend during the period 1951-2011.

Average population shared vis-à-vis Power shared:

The average population share in percent for Meitei, Scheduled Tribe and Meitei Pangal for 1951-2011 are given in the Table-14 below. This average has been adopted to normalise the population ratios.

From the Table-14 above, it is seen during 1999-2023 against the population share of 59.25 % by Meitei population, power shared was 60.35%. Similarly, against the population share of 33.36 % by Scheduled Tribe population, power shared during 1999-2023 was 30.78%. Similarly, against the population share of 7.25 % by Meitei Pangal population, power shared was 4.30%.

Findings of the Study:

- i. The percentage share of Meitei population declined during the period 1951 -2011.
- ii. The percentage share of Scheduled Tribe population increased during the period 1951 -2011.
- iii. MLAs shared maximum power with 56.91 % of the total power followed by Ministers sharing 22.16 % of the power. DCs shared with 2.14%.
- iv. Correlation analysis shows that during the period of 25 years (1999-2023), the increase of power for Meitei was associated with the increase of power for Tribal. Similarly, Meitei had positive correlation with Meitei Pangal.
- v. However, Correlation analysis further shows that the increase of power for Meitei was associated with the decrease of power for Outsiders. Similarly, the increase of power for Tribal was associated with the decrease of power for Outsiders.
- vi. The Study shows that against the average population share of 59.25 % by Meitei population the total power shared was 60.35%.
- vii. The Study also shows that against the average population share of 33.36 % by Scheduled Tribe/Tribal population the total power shared was 30.78%.
- viii. Thus, from the study it can be concluded that the power sharing between the Meitei population and Scheduled Tribe population during 1999-2023 was fairly distributed with minor departures from population ratios.
 - ix. The study further reveals that Scheduled Tribe of Manipur represented well in the administration of the State Government during the period 1999-2023.
 - x. The Outsiders played important pivotal role in the Government administration.

Conclusion of the Study:

- i. Scheduled Tribe community participated well in the Government administration sharing a reasonable power ratio during the period of 25 years (1999-2023).
- ii. The Outsiders played important pivotal role in the Government administration.
